Eligibility

The Raffle is offered, through EFCST officers, directors, members, staff and persons authorized by EFCST to sell tickets, to all persons who are 18 years of age or older or will be on August 23, 2008. All federal, state, and local laws and regulations apply.

Only EFCST Will Benefit From Raffle Net Proceeds

All Raffle net proceeds will benefit the charitable purposes of the EFCST. EFCST is a non-profit organization founded in 1994 to improve the lives of the almost 190,000 adults and children with epilepsy in the 79 counties of Central and South Texas.

Prize

1st Prize - One (1) Twenty-Five Hundred Dollar (\$2,500) MasterCard® gift card and Two (2) Southwest Airline round trip airline tickets.

2nd Prize – One (1) Fifteen Hundred Dollar (\$1,500) MasterCard® gift card

How to Enter

Each raffle ticket is valued at \$20. You may purchase as many tickets as you would like. Tickets must be purchased from a director, officer, member or staff member of EFCST or person authorized by EFCST to sell tickets.

Selection of Winner

The Winner will be determined by a random drawing from the eligible entries. All decisions are final and binding. Odds of winning first prize are estimated to be 1:2000 but are dependent on the final, actual number of participants entered in the Raffle on August 23, 2008 at 12:00 PM CDT. The Winner

will be notified by fax, e-mail, telephone, or regular mail. EFCST is not responsible for and shall not be liable for late, lost, misdirected, or unsuccessful efforts to notify winner.

The drawing will be held in Lubbock, Texas, at a place determined by the management of EFCST, on August 23, 2008 at 3:00 PM CDT. EFCST will pick one prize winner for each prize and one alternate ticket, which will be held and used only if the prize winners do not claim the prize in person at the offices of EFCST by 12:00 PM (Noon) CDT, August 31, 2008. Winner need not be present at the drawing to win. If not present, EFCST will make all reasonable attempts to notify the winner within 72 hours of the drawing. If the winner either can not be contacted after reasonable attempts by EFCST or fails to claim the prize, the prize will revert back to EFCST and the alternate ticket will be used as a winner. If an alternate winner is named the alternate winner will have fourteen (14) days to claim the prize in person at the offices of EFCST.

Winners
